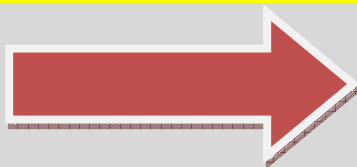

In order to **complete your visa application** you are required to complete the online visa order form as per the **link highlighted in yellow**. Completing the visa order form allows you to:

- ✓ Select the visa type you require
- ✓ Select the processing time you require
- ✓ Select the delivery and return instructions
- ✓ Highlight the main contact person responsible for the application
- ✓ Make secure online payment for the visa, and receive a VAT invoice

I accept that application fees are not refundable, except as covered by VFS's refund policy, and are payable even if a visa is not granted.
